## PLEASE READ AND SIGN THE FOLLOWING SERVICE AGREEMENT

I. <u>PURPOSE</u>: Callisburg Water & Sewer is responsible for protecting the drinking water supply from contamination or pollution which could result from improper plumbing practices. The purpose of this service agreement is to notify each customer of the plumbing restrictions which are in place to provide this protection. The utility enforces these restrictions to insure the public health and welfare. Each customer must sign this agreement before Callisburg Water & Sewer will begin Service. In addition, when service to an existing connection has been transferred the Water System will not reestablish service unless it has a signed copy of this agreement.

## II. <u>PLUMBING RESTRICTIONS</u>: The following undesirable plumbing practices are prohibited by State regulations.

- **A.** No direct connection between the public drinking water supply and a potential source of contamination is permitted. Potential sources of contamination shall be isolated from the public water system by an air-gap or an appropriate backflow prevention device.
- **B.** No cross-connection between the public drinking water supply and a private water supply system is permitted. These potential threats to the public drinking water supply shall be eliminated at the service connection by an air-gap or a reduced pressure-zone backflow prevention device.
- **C.** No connection which allows condensing, cooling, or industrial process water to be returned to the public drinking water supply is permitted.

- **D.** No pipe fitting which contains more than 8.0% lead may be used for the installation or repair of plumbing at any connection which provides water for human use.
- **E.** No solder or flux which contains more than 0.2% lead can be used for the installation or repair of plumbing at any connection which provides water for human use.

## **III.** <u>SERVICE AGREEMENT</u>: The following are the terms of the service agreement between Callisburg Water & Sewer and applicant.

- **A.** The water system will maintain a copy of this agreement as long as the customer and/or the premises are connected to the water system.
- **B.** The customer shall allow his property to be inspected for possible cross connections and other undesirable plumbing practices. These inspections shall be conducted by the water system's designated agent prior to initiating service and periodically thereafter. The inspection shall be conducted during the water system's normal business hours.
- **C.** The water system shall notify the customer in writing of any cross connections or undesirable plumbing practices which have been identified during the initial inspection or the periodic inspection.
- **D.** The customer shall immediately correct any undesirable plumbing practices.
- **E.** The customer shall, at his expense, properly install, test, and maintain any backflow device required by the water system. Copies of all testing and maintenance records shall be provided to the water system.
- IV. <u>ENFORCEMENT</u>: If the customer fails to comply with the terms of the service agreement, the water system shall at its option either terminate service or properly install, test and maintain an appropriate back-flow prevention device at the service connection. Any expense associated with the enforcement of this agreement shall be billed to the customer.
